#### **B. Refund Policy of Academic Fees for First Year Admissions**

1. If a student having, allotted a seat in IIITT, fails to report at the Institute in accordance with the schedule of JoSAA / CSAB and the Institute receives his/her fees from the Authority, the same shall stand forfeited and the student shall not be eligible for any refund.
2. If a student having, reported at IIITT, fails to register at the Institute in accordance with the schedule of the Institute and the Institute receives his/her fees from the Authority, the same shall stand forfeited and the student shall not be eligible for any refund.
3. If a student submits his/her request for admission cancellation within 30 days after conclusion of the Centralized Admission Process and no further rounds of admissions are conducted by CSAB/ JoSAA to fill the vacant seat arising due to such admission cancellation, the entire “Tuition Fees” shall stand forfeited. However, the student shall receive refund of full Caution Deposits (Institute & Hostel) upon payment of Full Fee including Hostel Fee to the Institute.
4. If a student submits his/her request for admission cancellation after 30 days after conclusion of the Centralized Admission Process and no further rounds of admissions are conducted by JoSAA/ CSAB to fill the vacant seat arising due to such admission cancellation, the student shall not be eligible for any refund.
